## THE PLAN

- Policy-Based Document [48 Goals]
  - Preserve the bucolic residential character of the community's neighborhoods.
  - Locate higher density residential development in the hamlets, with density of development decreasing as distance from hamlet centers increases.
  - Create a sustainable mix of commercial and residential uses within the hamlets.
  - Ensure adequate infrastructure service to meet existing and future demand (i.e. roads, stormwater, microgrids, fire suppression).


